1.0 DESCRIPTION

Seal Ring Lubricant is specially formulated pipe lubricant for use with concrete pipes having skid ring type joints. It is non-toxic and fully soluble in water.

3.0 USES

Seal Ring Lubricant is used to lubricate the inside of concrete pipes with skid ring type joints. It is non aggressive to rubber and concrete and may be applied by hand. Seal Ring Lubricant may also be used for other applications where a non-toxic, water-soluble lubricant is required (not tested for potable water contact).

4.0 APPLICATION

Apply liberally by hand to the inside of the faucet.

Where chevron rings are used it is advisable to ensure that the area immediately under the ring is well lubricated. This will allow the chevron ring to readily flatten out to its final sealing position.

Precautions should be taken to ensure that rubber rings and contact faces are well cleaned before the lubricant is applied.

After use, the lubricant can be easily removed from hands by washing in warm or cold water.
