# PROTECTA-SIGN GRAFFITI REMOVER

### TECHNICAL DATA

## 1.0 DESCRIPTION

A solvent-based, highly effective water-soluble graffiti remover for a range of surfaces either protected by PROTECTA-SIGN ANTI-GRAFFITI COATING or plain, unprotected surfaces.

PROTECTA-SIGN GRAFFITI REMOVER is highly effective on most forms of graffiti and can be easily washed from the surface with clean water after application.

## 2.0 PHYSICAL PROPERTIES:

## 3.0 USES

For the removal of graffiti from signs (vinyl, enamel, powder coated) and dense granite, marble and concrete. Also used to remove graffiti from surfaces treated with PROTECTA SIGN ANTI GRAFFITI COATING. Not suitable for use on latex painted surfaces as it may dissolve the underlying paint.

## 4.0 APPLICATION INSTRUCTIONS

### Test before Use

Test a small area first before proceeding with complete removal, as some plastic and vinyl signs (and other weaker surfaces) may be permanently damaged by PROTECTA-SIGN GRAFFITI REMOVER.

### Directions

Wear protective gloves, eye protection and in confined spaces, vapour protection. Read label completely before use and note all precautions regarding handling and use.

Use undiluted. Surface to be treated must be dry. Apply an even coating by brush. Allow time to soften graffiti before removing with water, preferably containing soap or detergent. Repeat as necessary.

After the removal of the graffiti, and when the substrate is clean and dry, apply PROTECTA-SIGN ANTI GRAFFITI COATING to aid in removal in the future.

Clean all tools in soap and water. Wash hands thoroughly.

## 5.0 PACKAGING

PROTECTA-SIGN GRAFFITI REMOVER is supplied in 4 litre and 20 litre containers.
